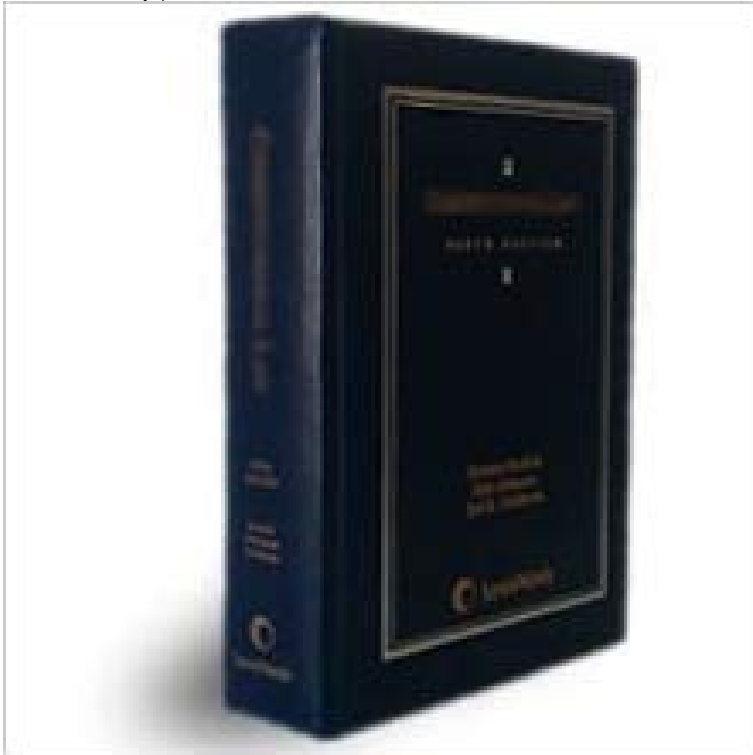


## Gaming Law: Cases and Materials
