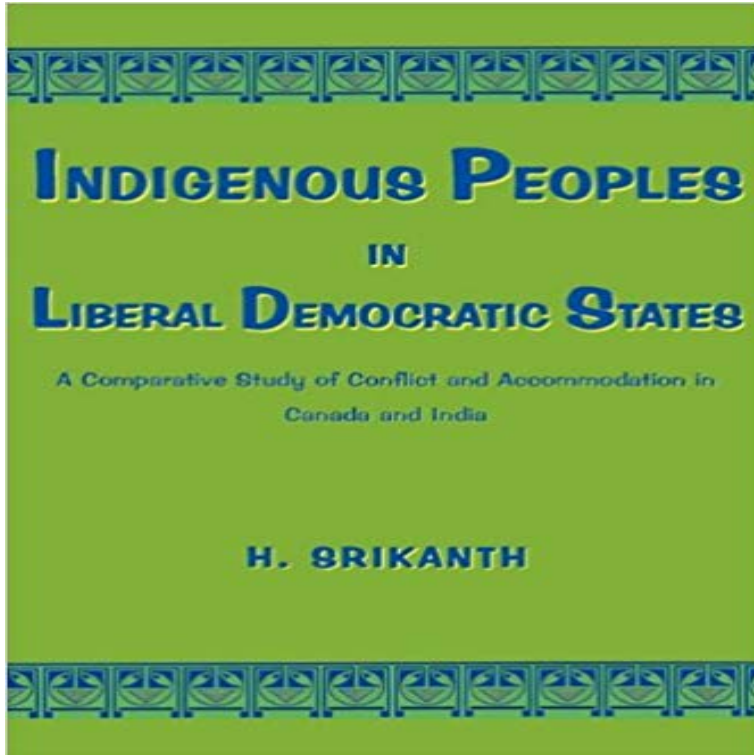


Indigenous Peoples in Liberal Democratic States: A Comparative Study of Conflict and Accommodation in Canada and India

Utilizing historical, comparative and analytical methods, the book throws light on the major concerns, achievements and failures of the indigenous peoples movements in Canada and India. By shedding light on the impact of colonial and post-colonial regimes on indigenous communities, the book critically evaluates different policies and strategies pursued in these countries to accommodate indigenous peoples fighting for protection of aboriginal rights. By analyzing Native resistance movements and State responses to these movements, the book explores the potentialities and limits of liberal democracies in addressing issues raised by indigenous movements for self-determination. The central themes are examined in light of contemporary discourses on the rights of indigenous people. Indigenous Peoples in Liberal Democratic States is an essential book for specialists and non-specialists alike, and it will interest all readers who are concerned about relationships between indigenous peoples and States.
