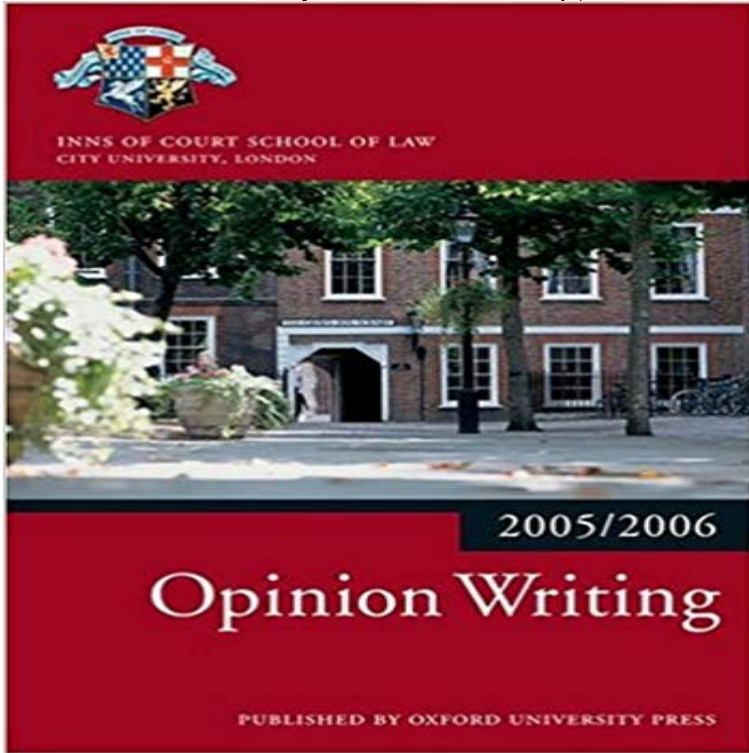


## Bar Manual: Opinion Writing 2005/6 (Blackstone Bar Manual)
