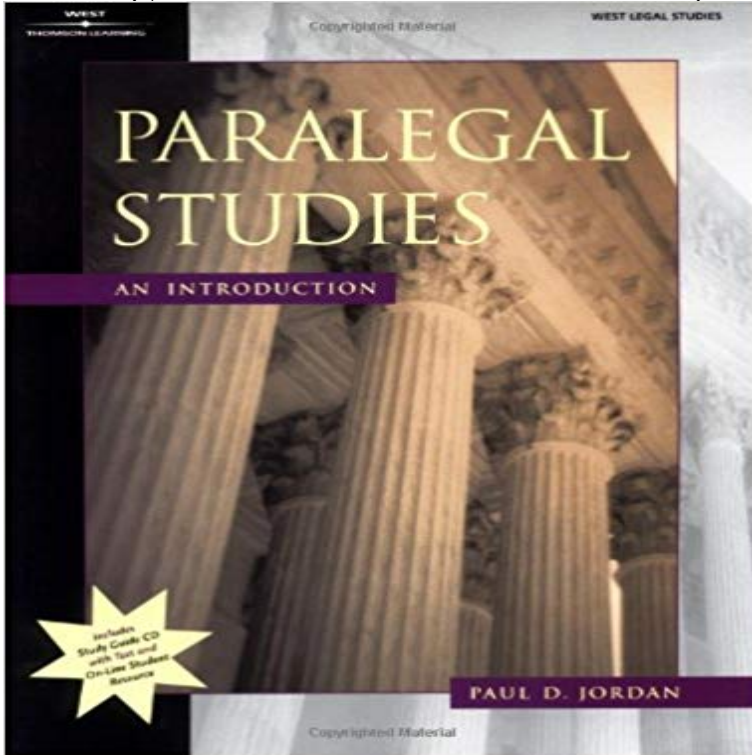


## Paralegal Studies: An Introduction (Paralegal Series)
