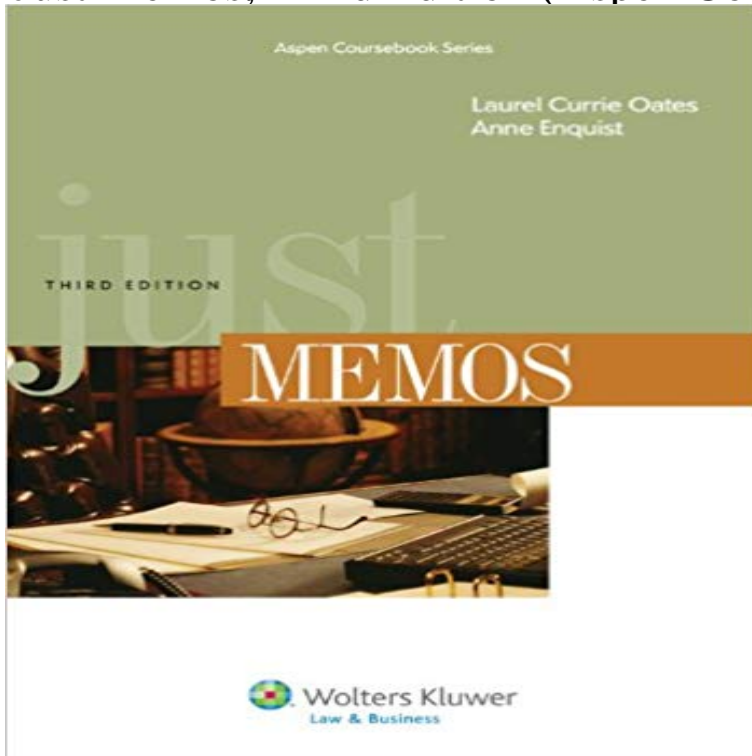


## Just Memos, Third Edition (Aspen Coursebook)
