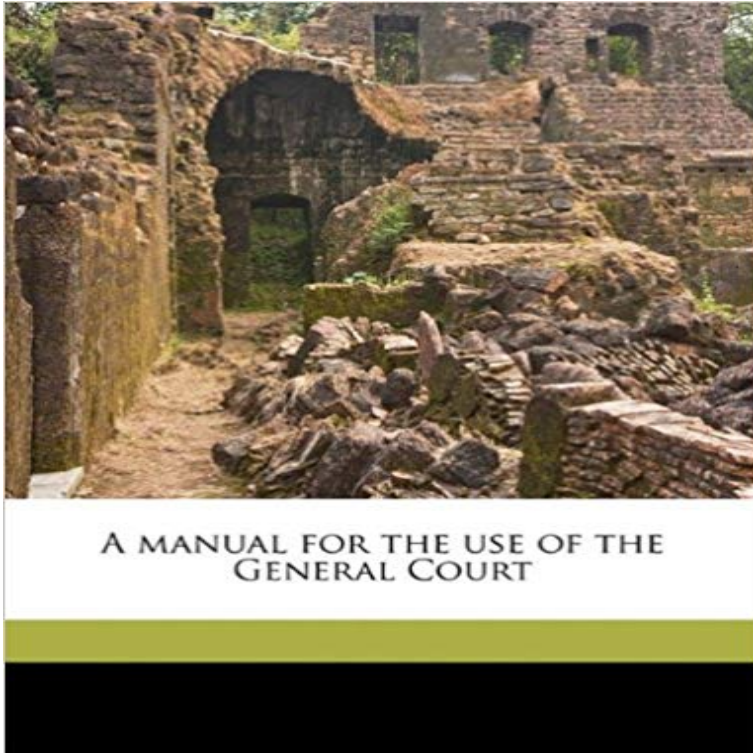


## A manual for the use of the General Court Volume 1951-52
