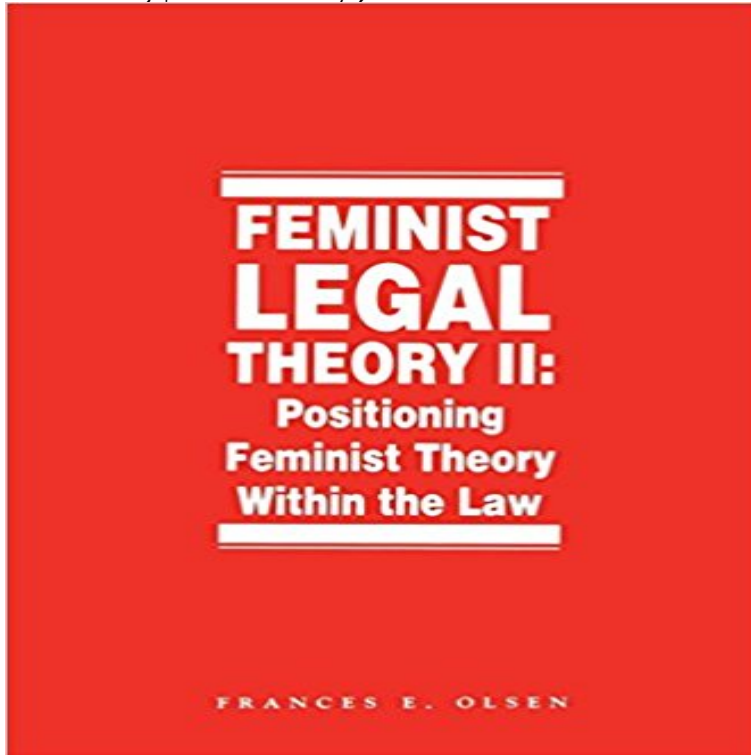


Feminist Legal Theory (Vol. 2) (International Library of Essays in Law and Legal Theory)
