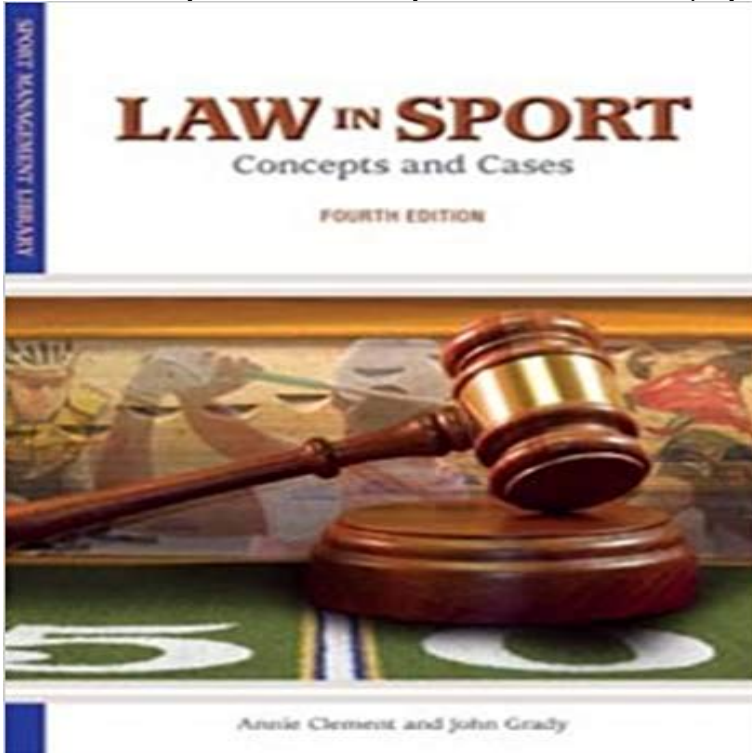


## Law in Sport: Concepts and Cases (Sports Management Library)
