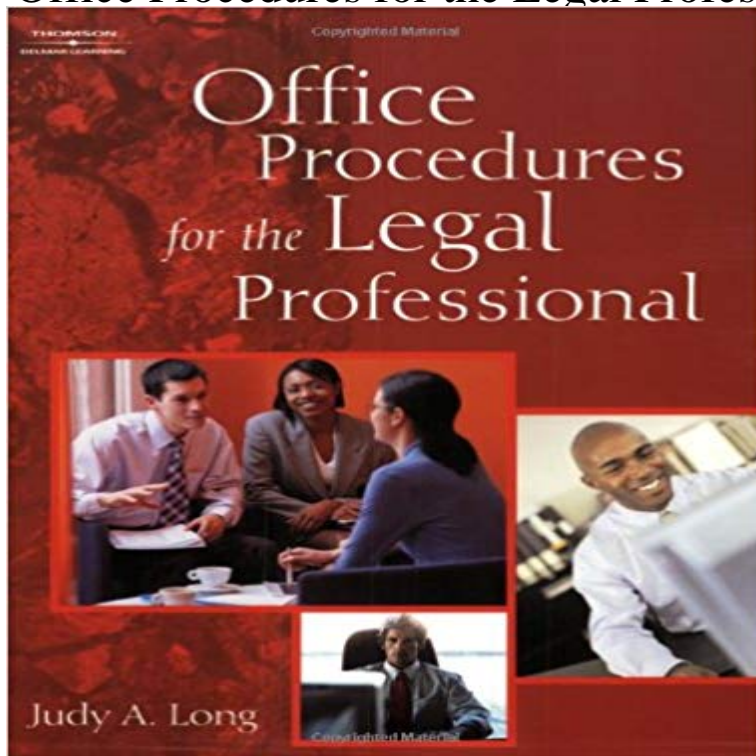


## Office Procedures for the Legal Professional (Legal Office Procedures)
