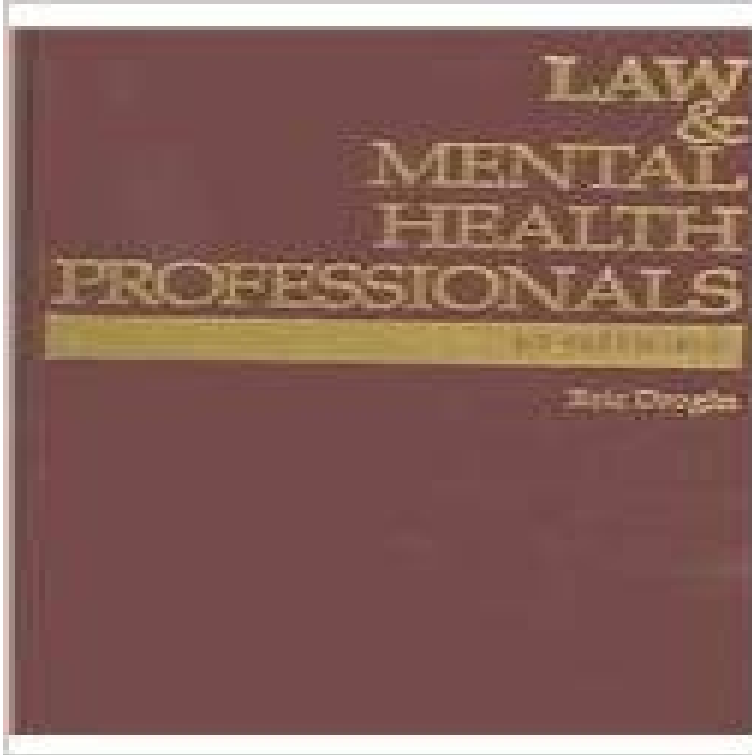


Law & Mental Health Professionals: Kentucky (Law and Mental Health Professionals)
