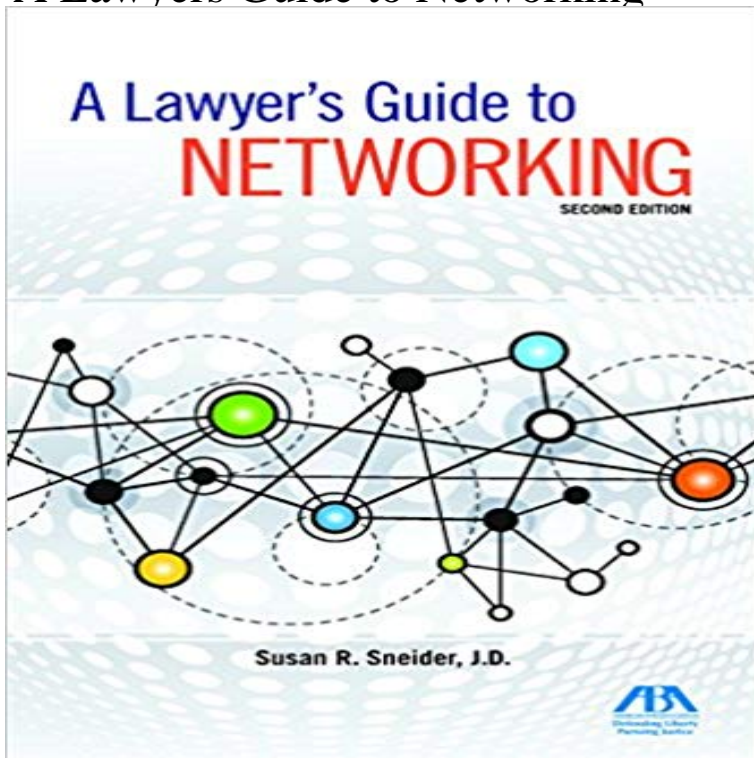


## A Lawyers Guide to Networking
