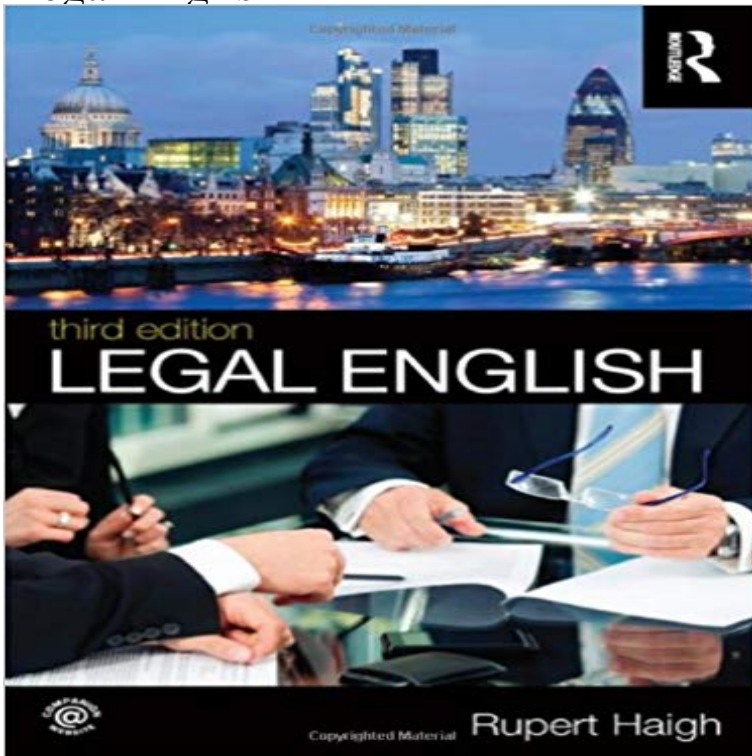


# Legal English
