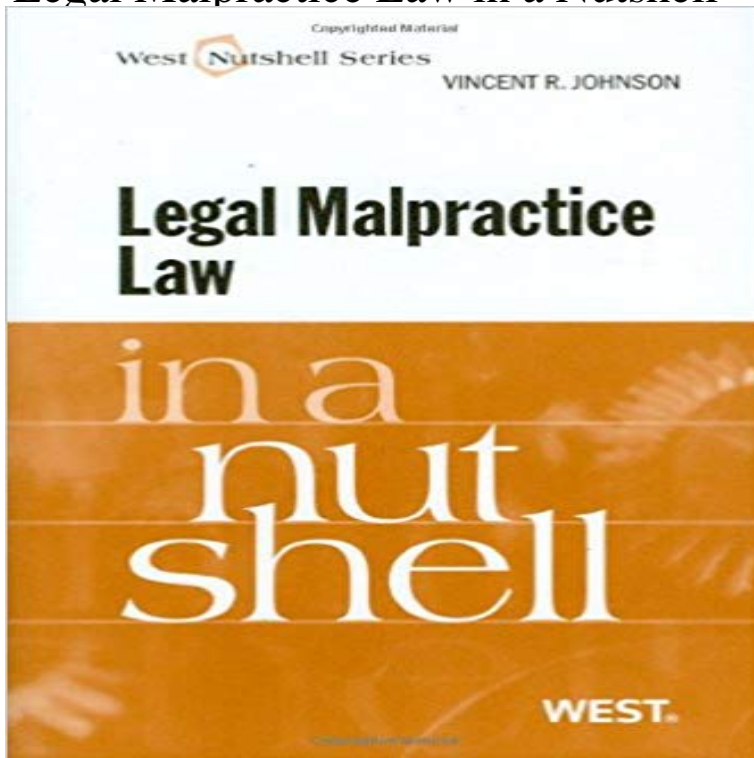


Legal Malpractice Law in a Nutshell
