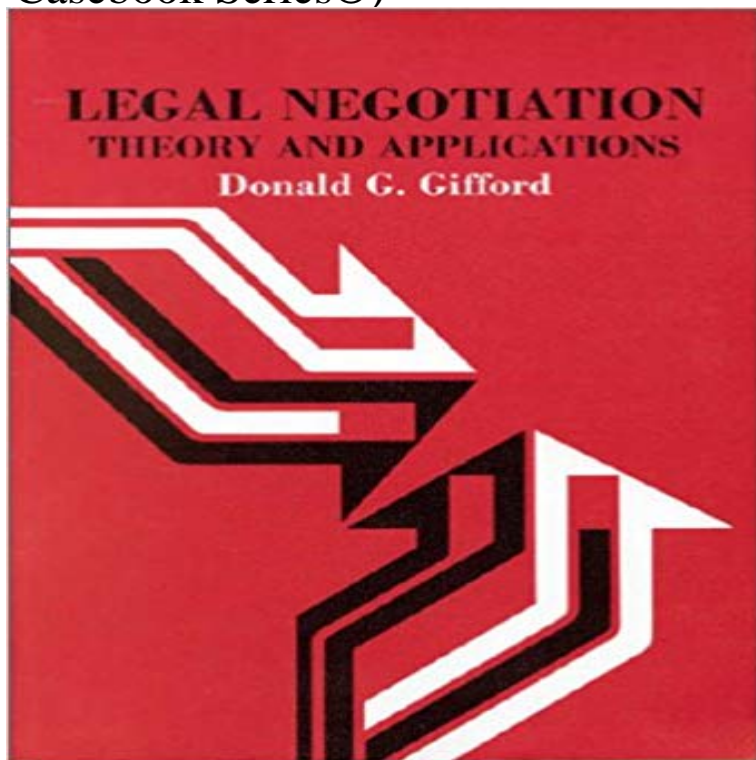


Giffords Legal Negotiation: Theory and Applications (American Casebook Series®)
