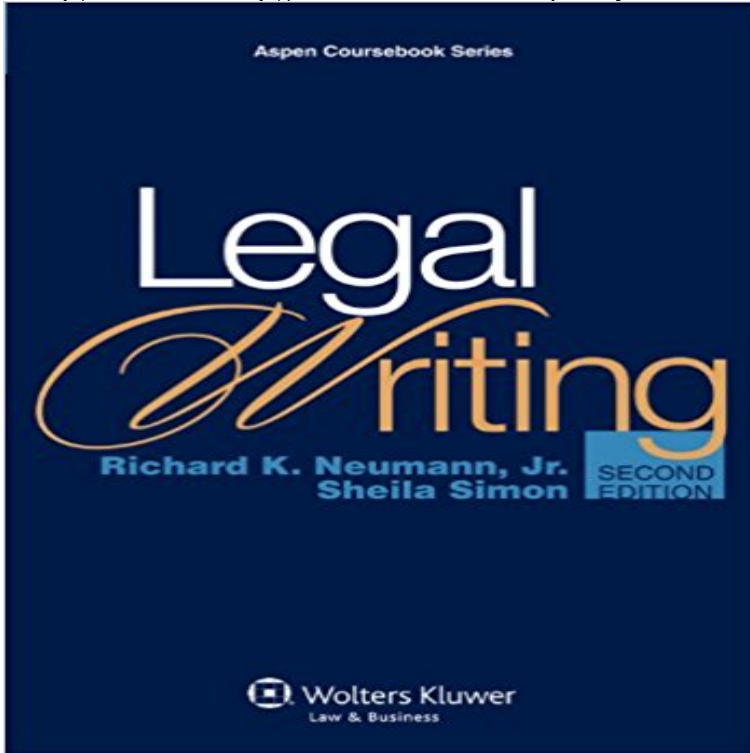


## Legal Writing, 2nd Edition (Aspen Coursebook Series)
