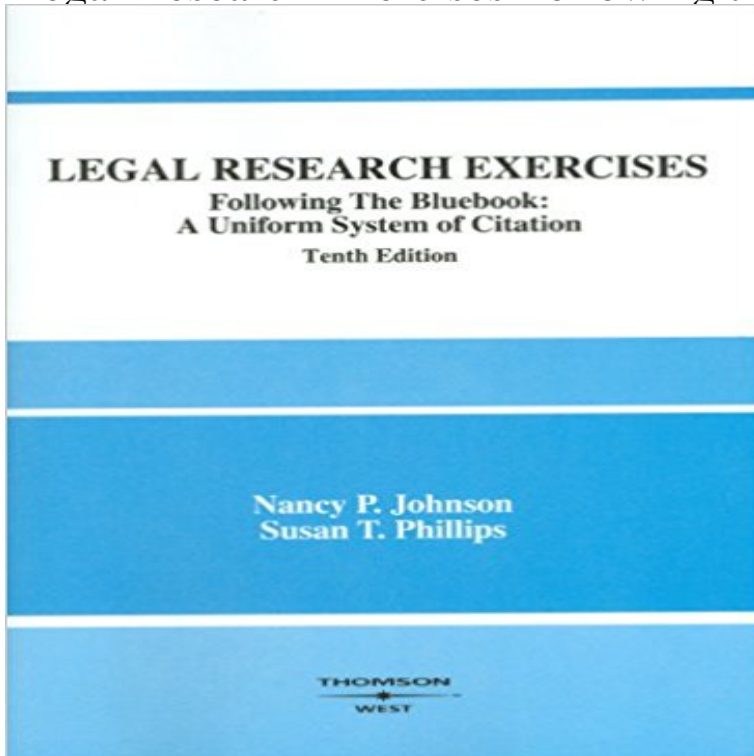


Legal Research Exercises Following the Bluebook (Tenth Edition)
