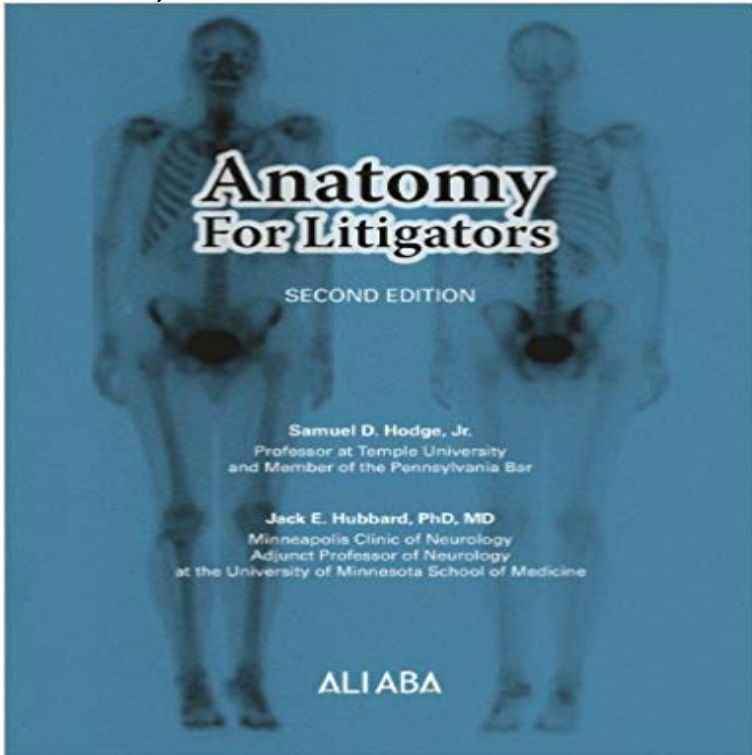


A Primer on Diagnostic Imaging (Anatomy For Litigators, Second Edition)
