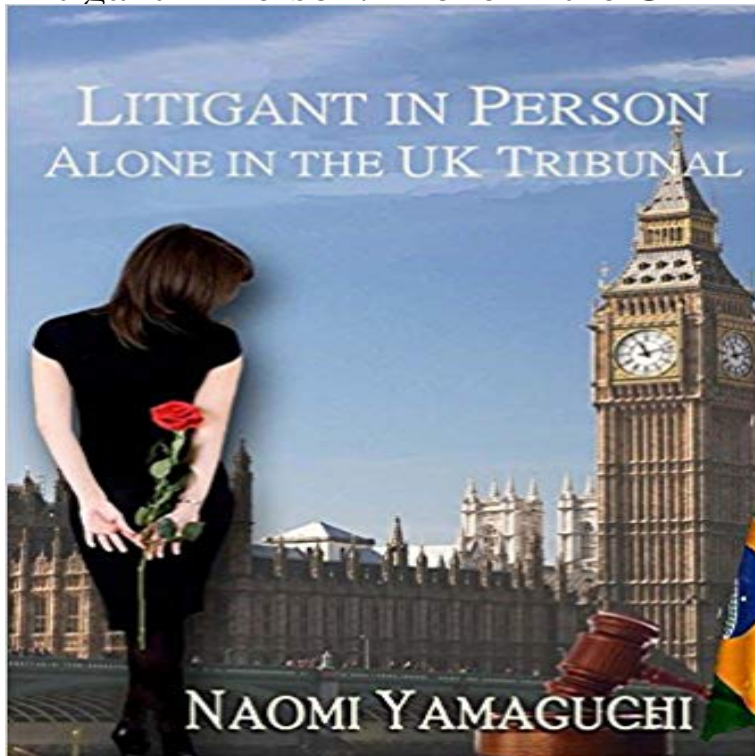


## Litigant in Person: Alone in the UK Tribunal
