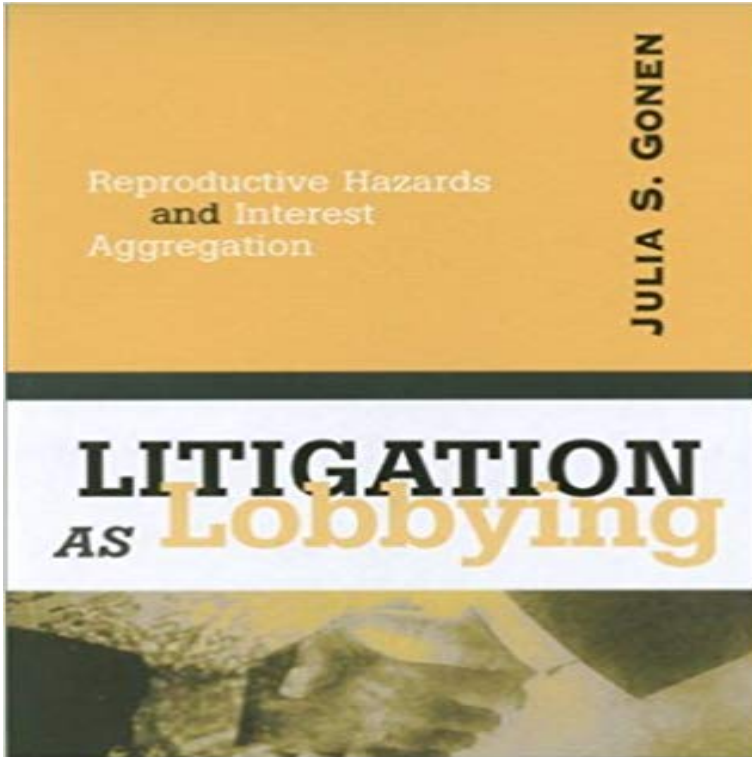


# LITIGATION AS LOBBYING: REPRODUCTIVE HAZARDS & INTEREST AGGREGAT
