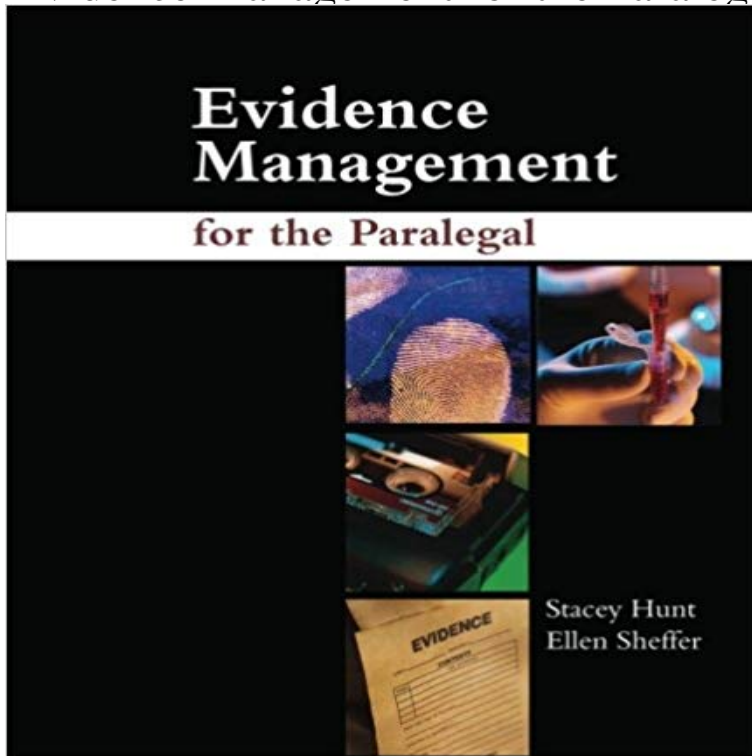


## Evidence Management for the Paralegal
