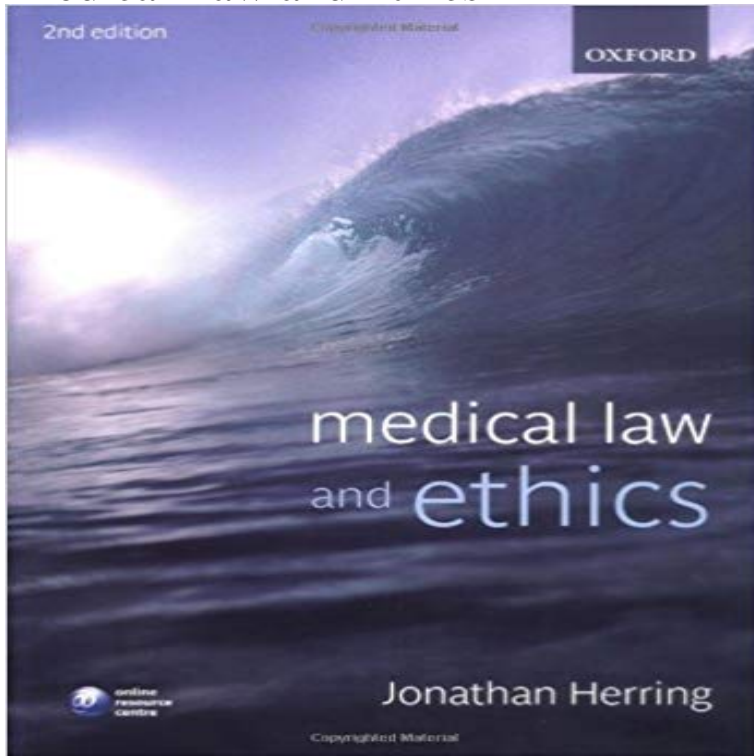


Medical Law and Ethics
