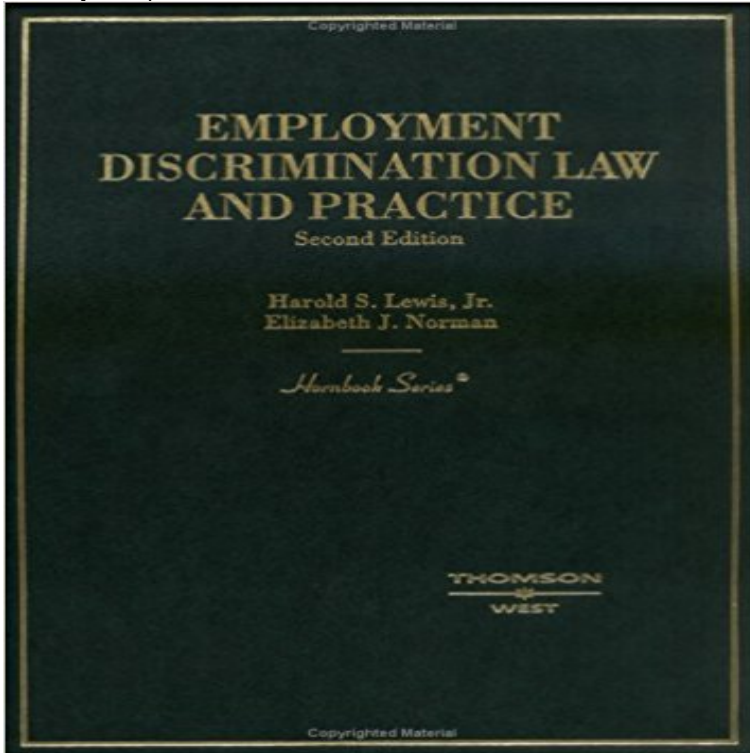


Employment Discrimination Law And Practice (Hornbook)
