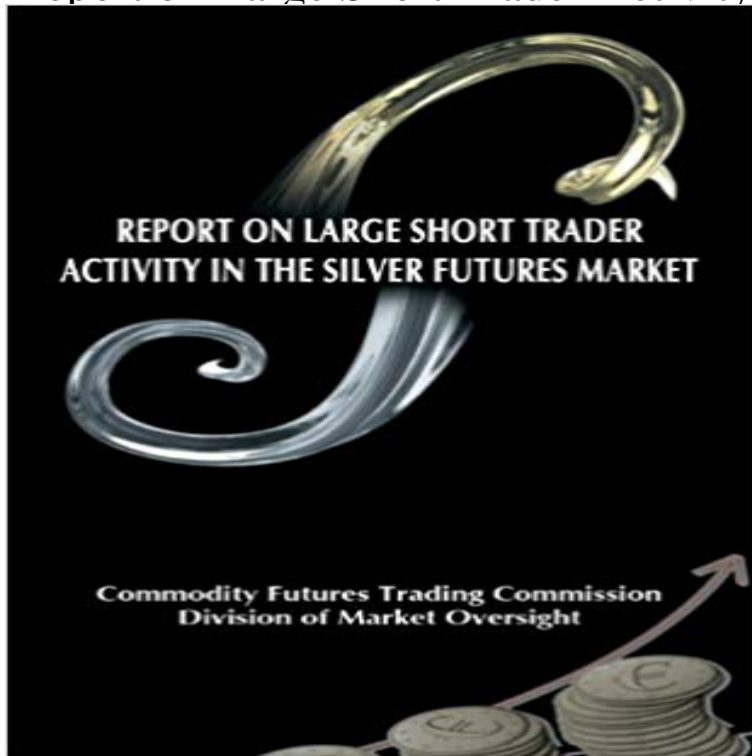


Report on Large Short Trader Activity in the Silver Futures Market

As a result, the Division of Market Oversight staff decided to revisit this issue by taking a fresh look at activity in the silver futures market.
