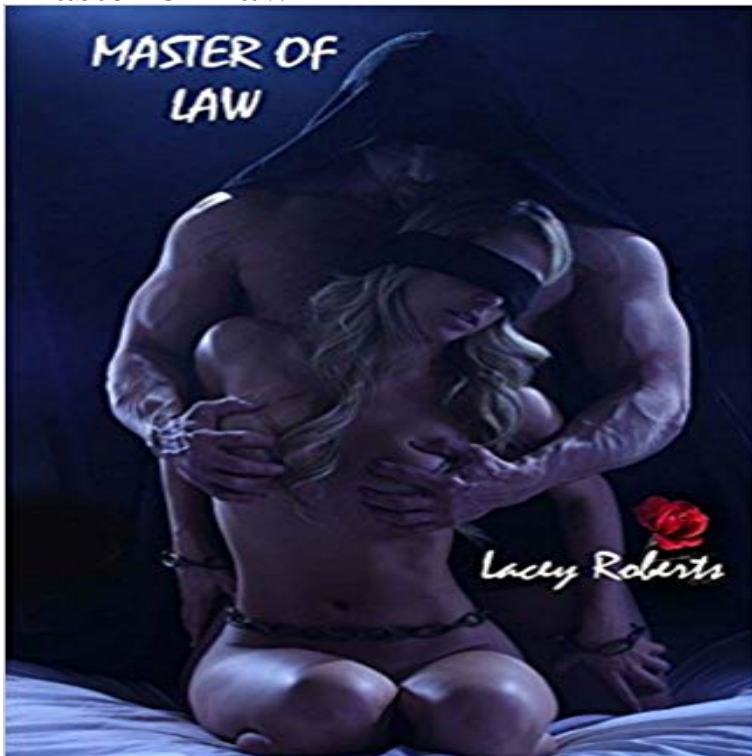


Master of Law
