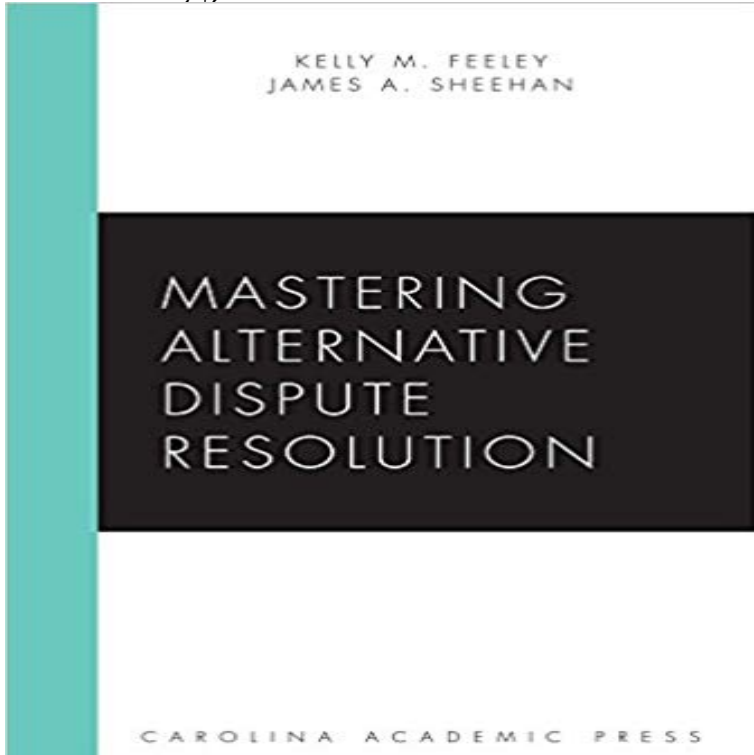


Mastering Alternative Dispute Resolution (Carolina Academic Press Mastering)
