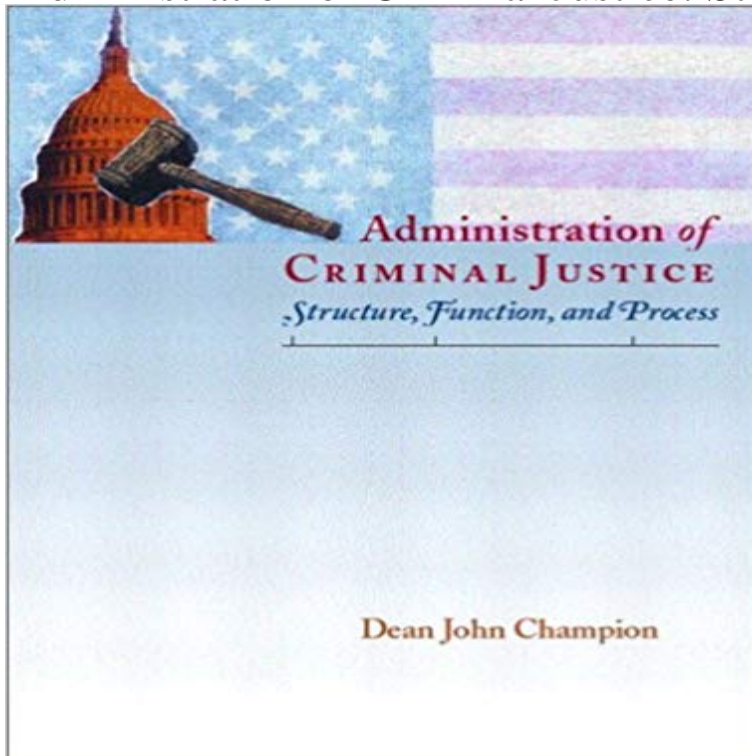


# Administration of Criminal Justice: Structure, Function, and Process
