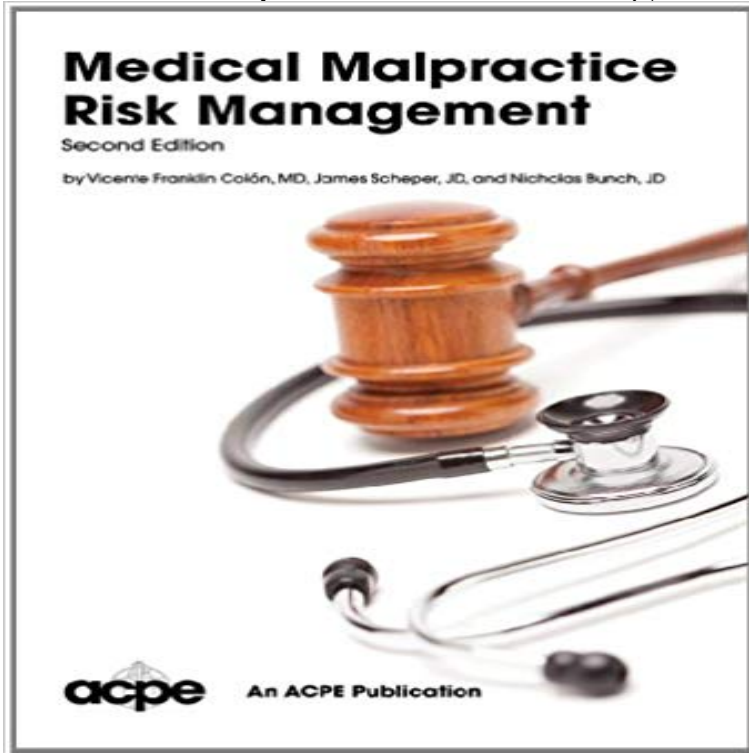


## Medical Malpractice Risk Management 2nd edition
