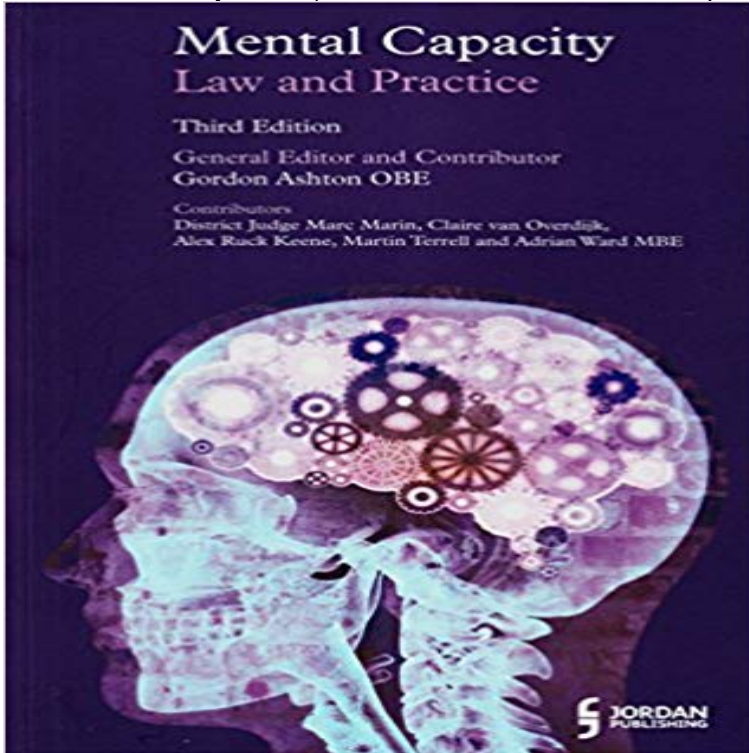


## Mental Capacity: Law and Practice (Third Edition)
