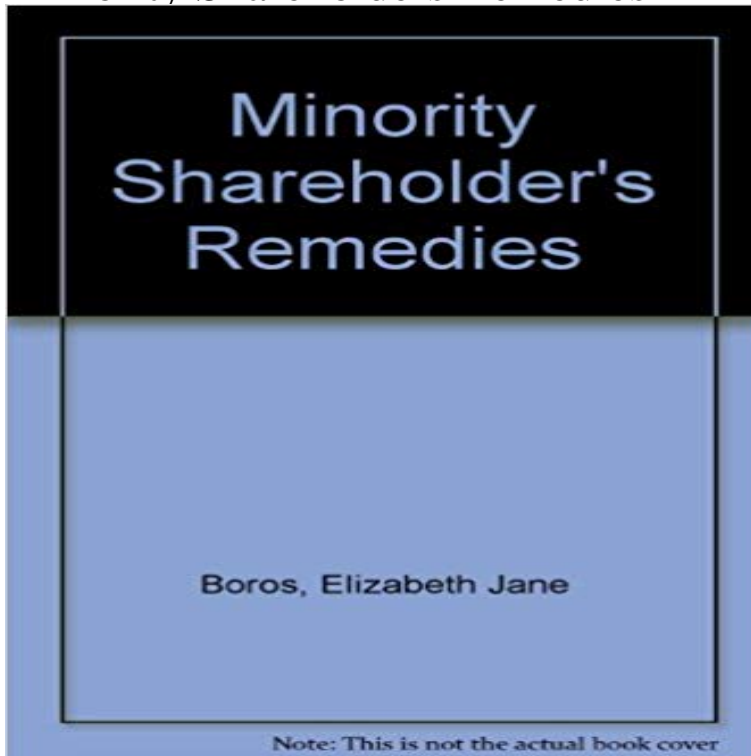


## Minority Shareholders Remedies
