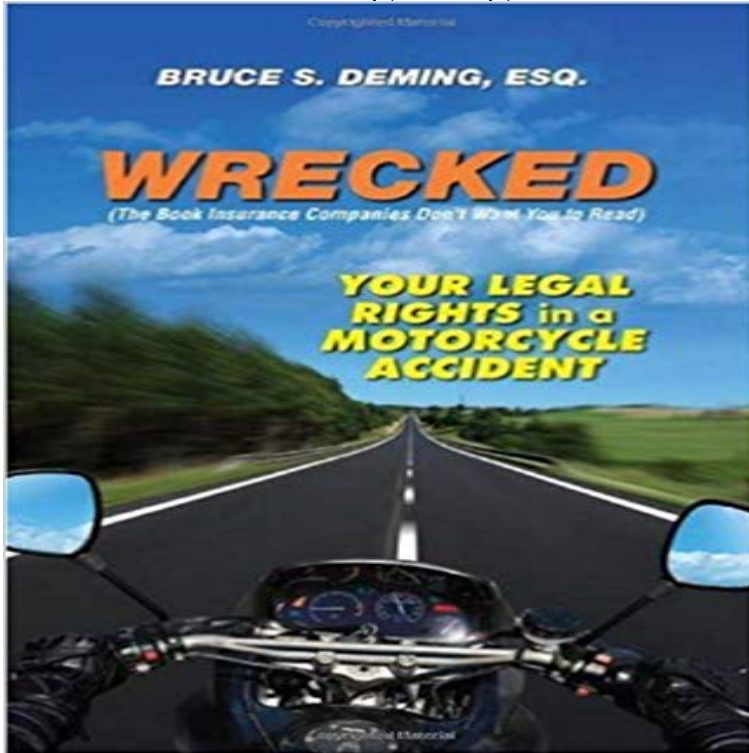


## Wrecked: Your Legal Rights in a Motorcycle Accident
