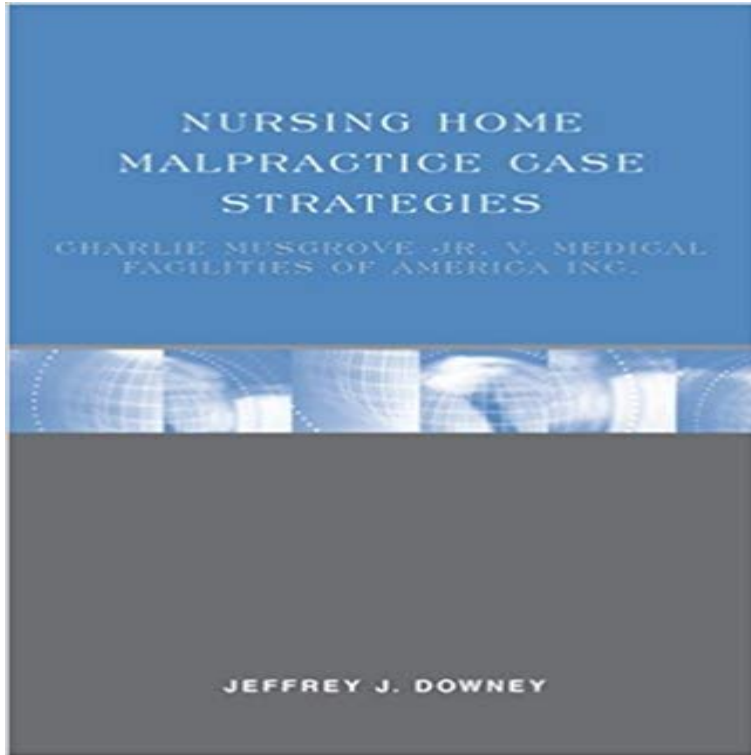


Nursing Home Malpractice Case Strategies: Charlie Musgrove Jr. v. Medical Facilities of America Inc.
