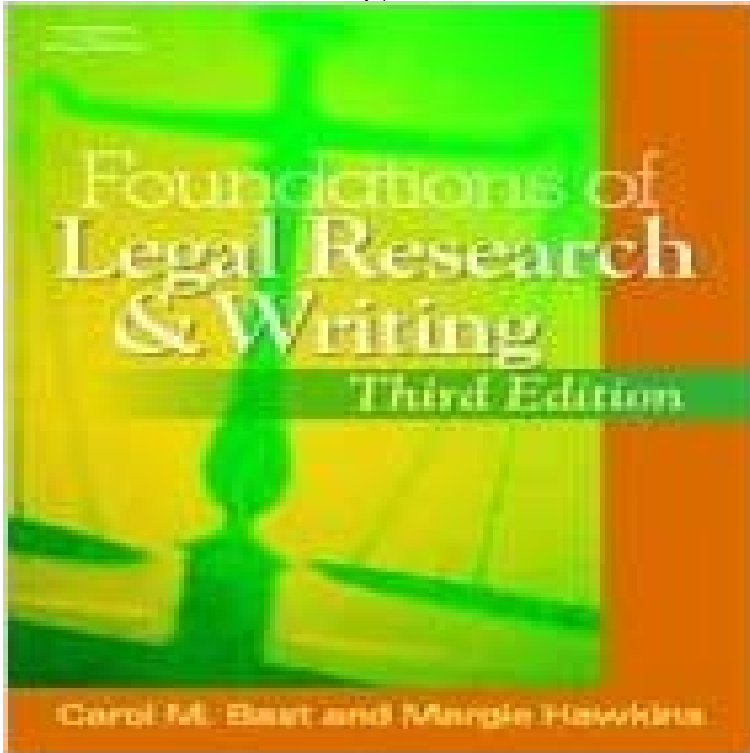


Foundations of Legal Research and Writing, 2E
