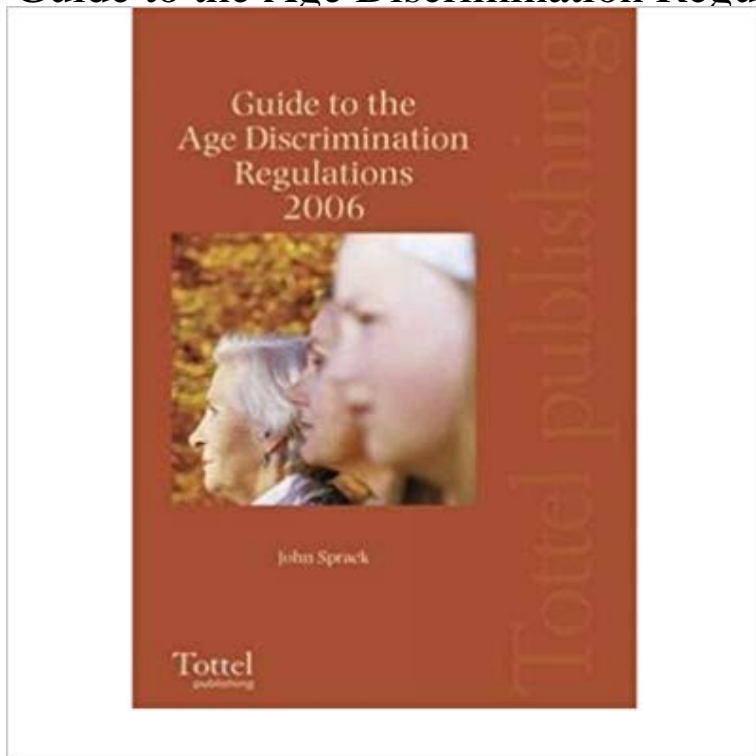


## Guide to the Age Discrimination Regulations (Paperback) - Common
