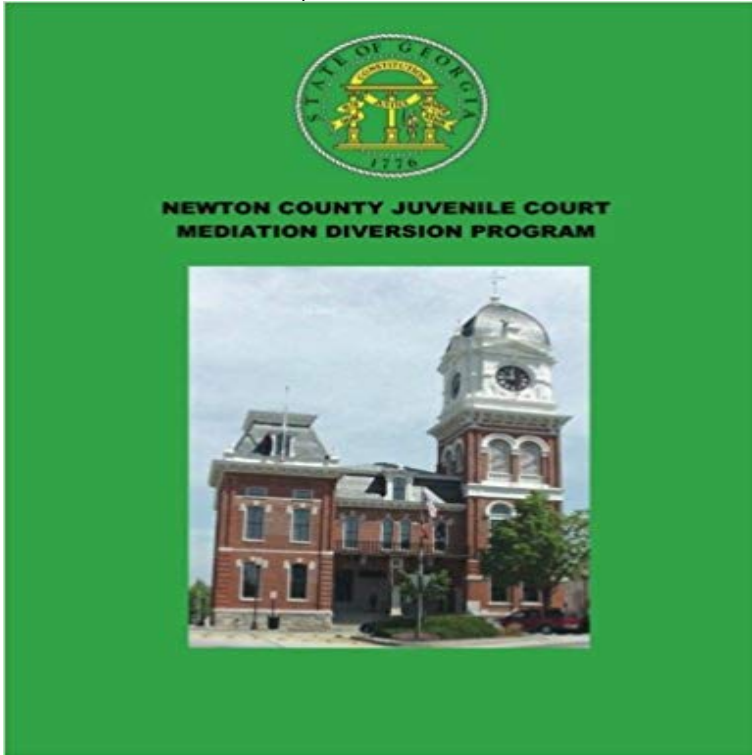


# Newton County Juvenile Court Mediation Diversion Program
