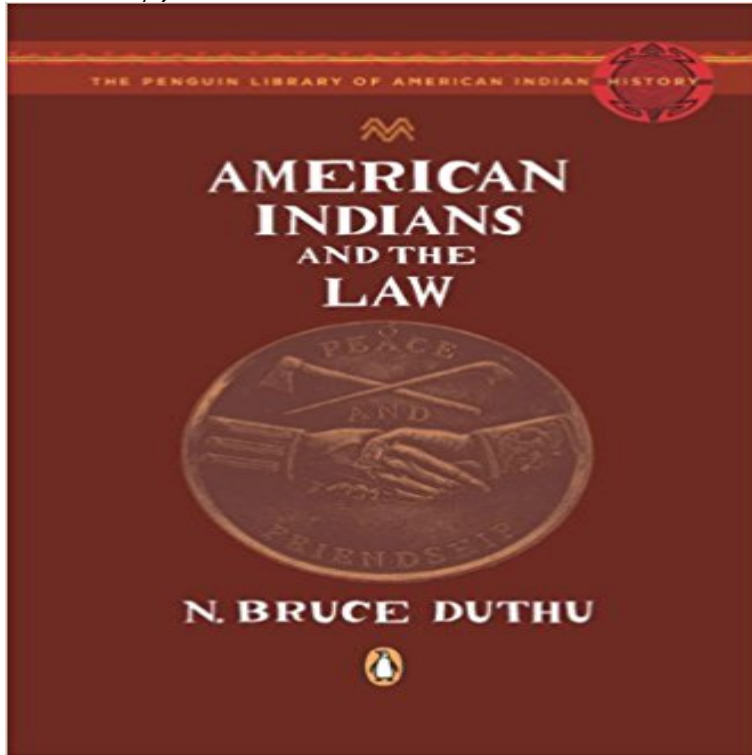


American Indians and the Law (The Penguin Library of American Indian History)
