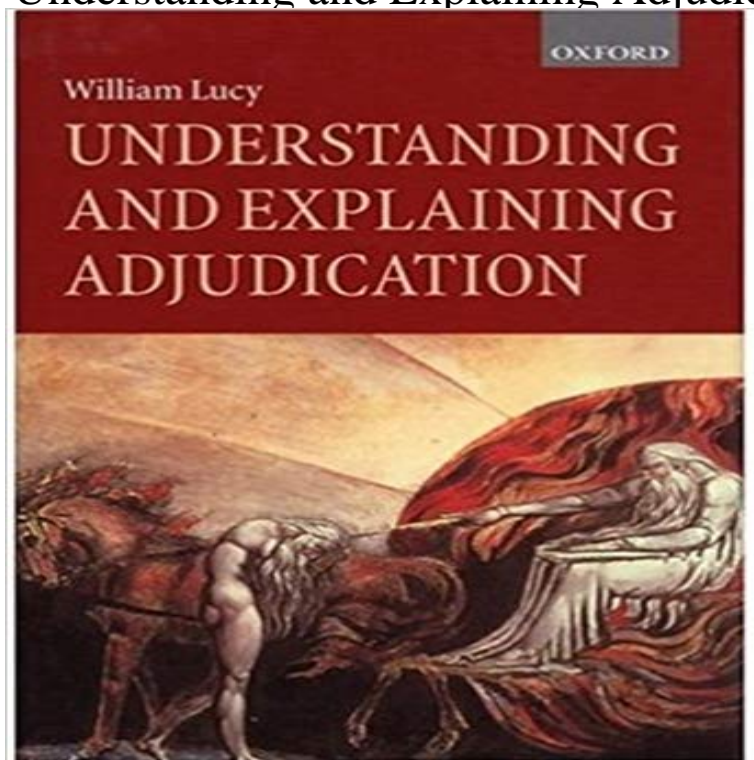


Understanding and Explaining Adjudication
