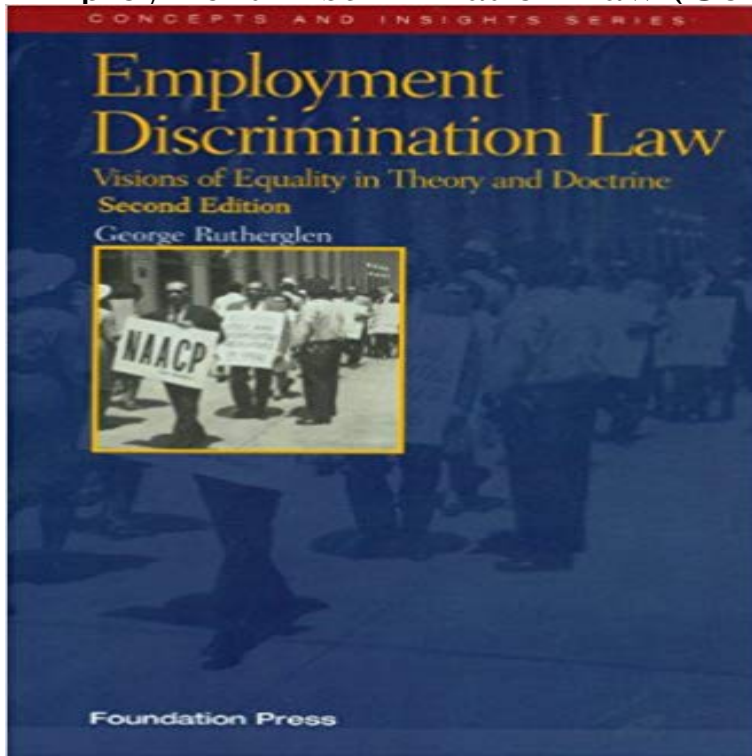


Employment Discrimination Law (Concepts & Insights)
