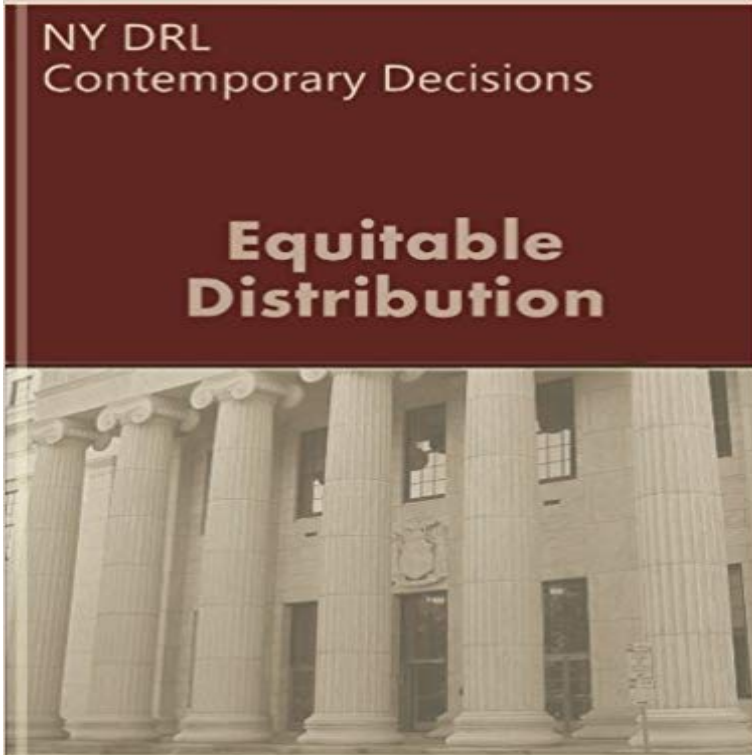


# NY DRL: Equitable Distribution - Contemporary Decisions (NY Litigator)



This casebook contains 262 appellate decisions of the State of New York that interpret and apply the equitable distribution provisions of the Domestic Relations Law. The selection of decisions spans from 2000 through the date of publication. The decisions are listed in the order of frequency of citation. Equitable distribution presents issues of fact to be resolved by the trial court and should not be disturbed on appeal unless shown to be an improvident exercise of discretion (*Loria v Loria*, 46 AD3d 768, 769-770). Equitable distribution does not necessarily mean equal distribution, and requires the courts consideration of all relevant statutory factors (*Faello v Faello*, 43 AD3d 1102, 1103; see Domestic Relations Law 236[B][5][d]). *Nidositko v.
