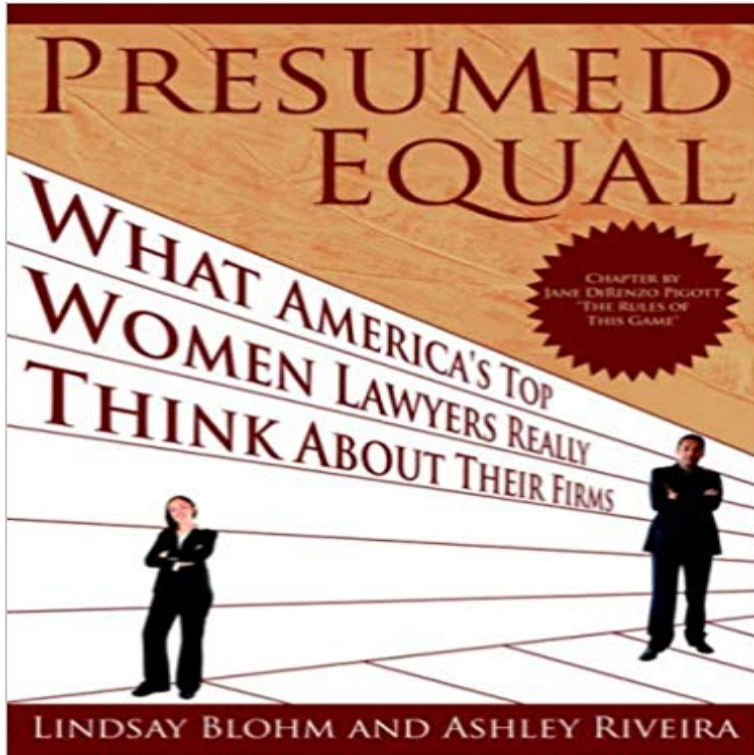


## Presumed Equal: What Americas Top Women Lawyers Really Think About Their Firms
