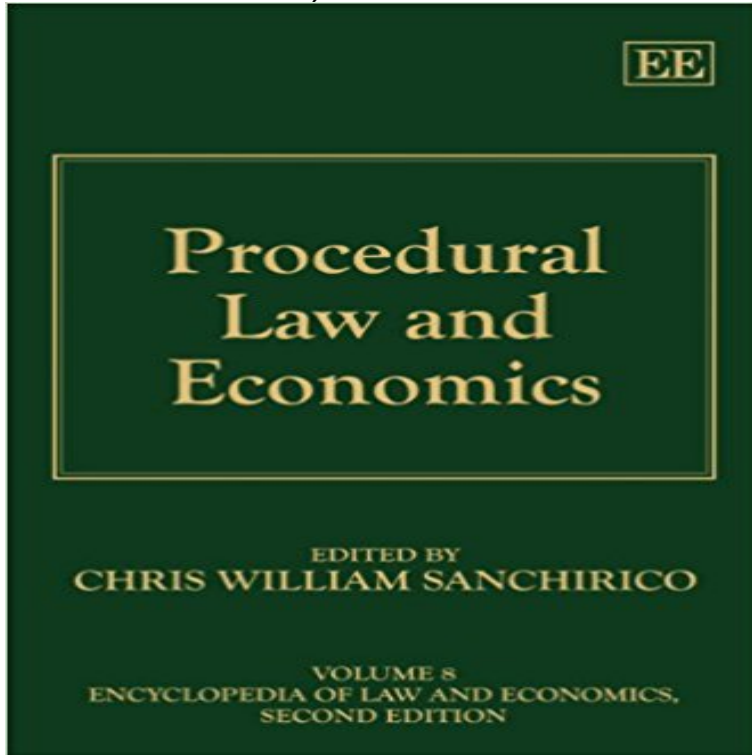


Procedural Law and Economics (Encyclopedia of Law and Economics, Second Edition)
