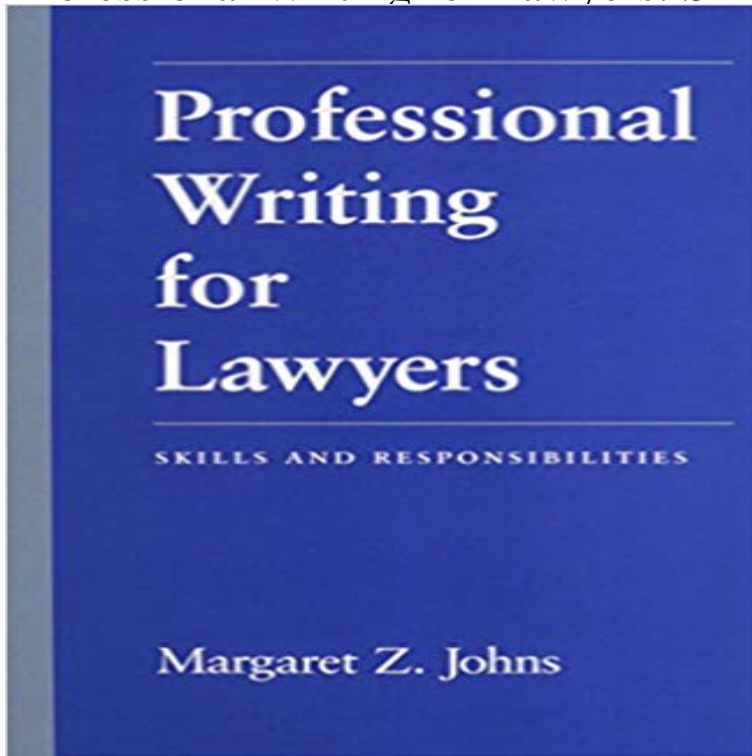


# Professional Writing for Lawyers: Skills and Responsibilities
