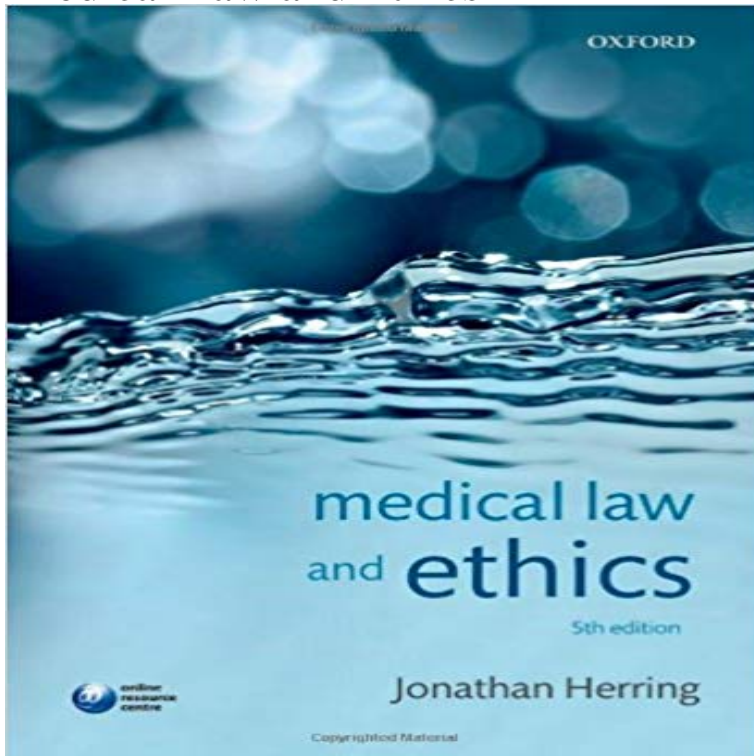


# Medical Law and Ethics
