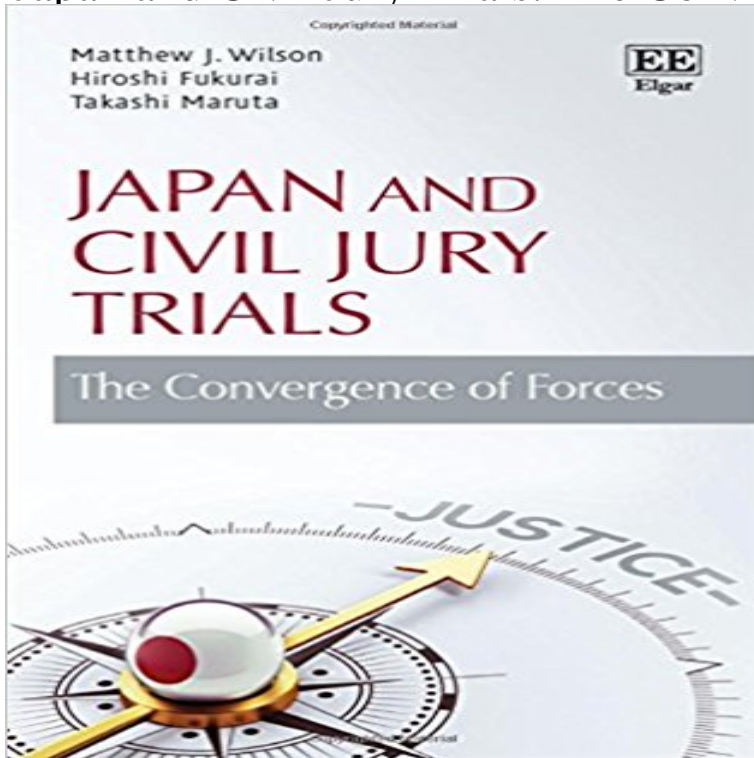


Japan and Civil Jury Trials: The Convergence of Forces
