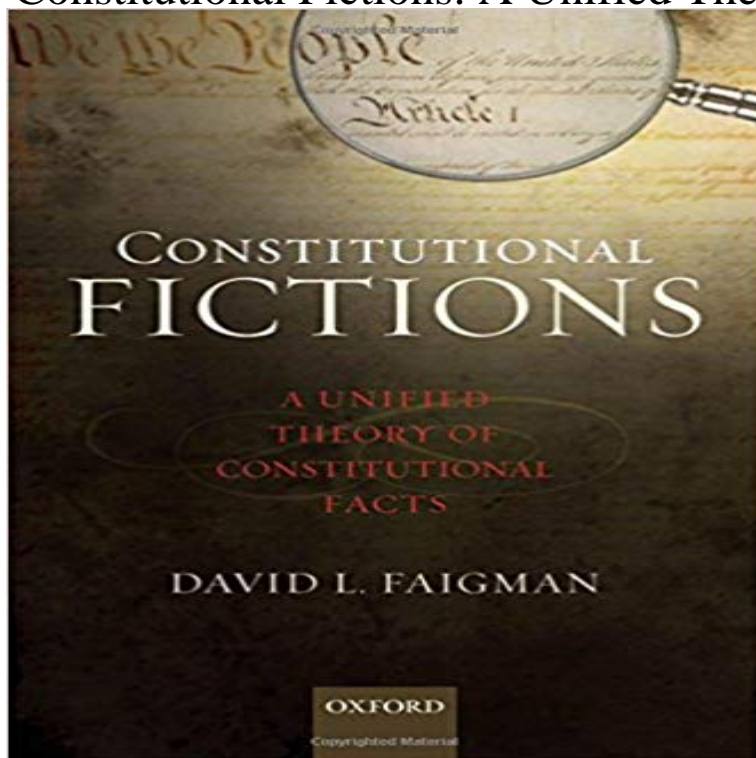


Constitutional Fictions: A Unified Theory of Constitutional Facts
