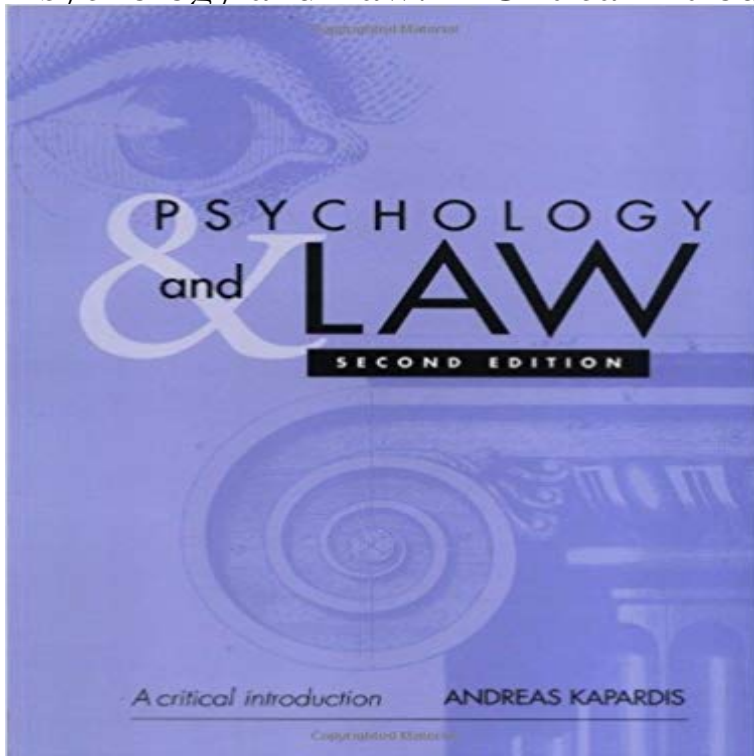


# Psychology and Law: A Critical Introduction
