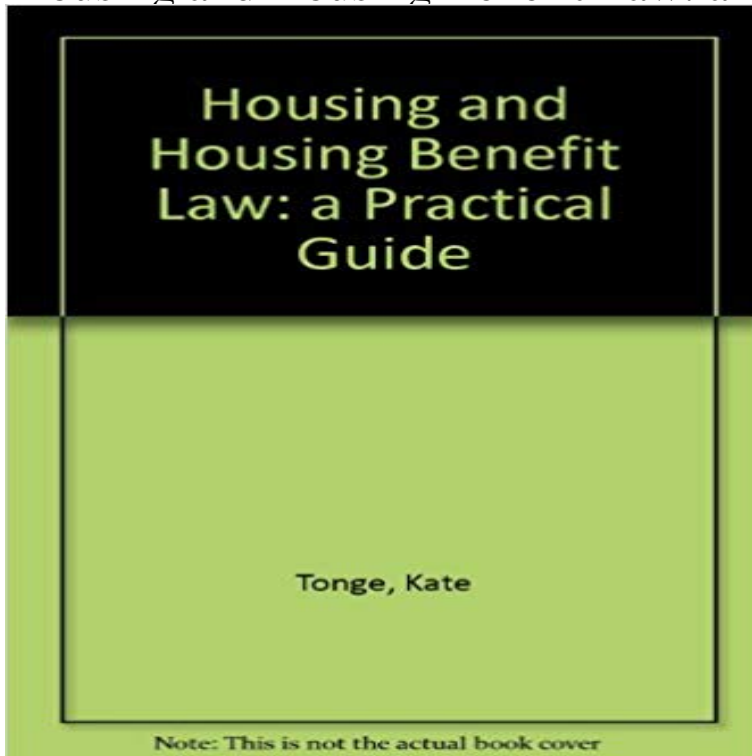


Housing and Housing Benefit Law: a Practical Guide
