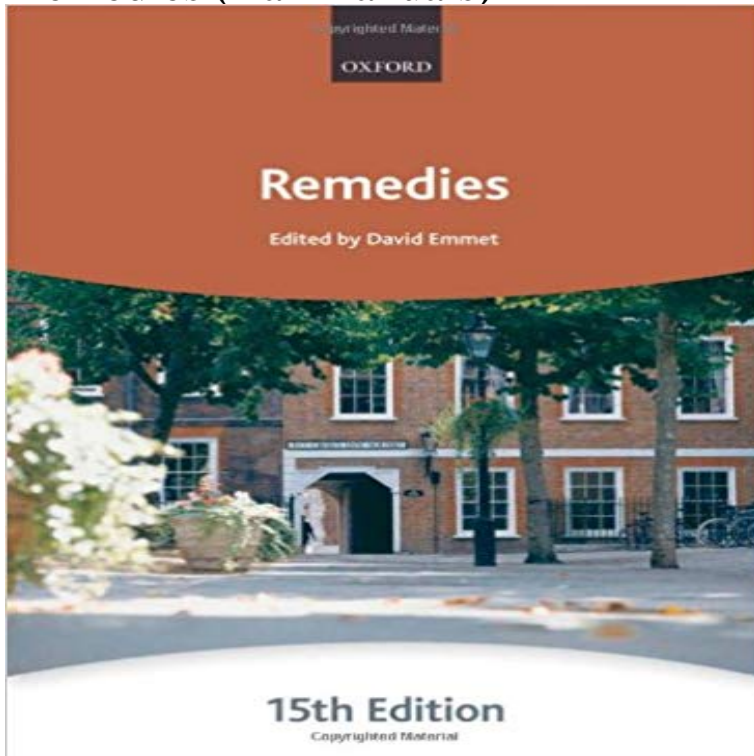


## Remedies (Bar Manuals)
