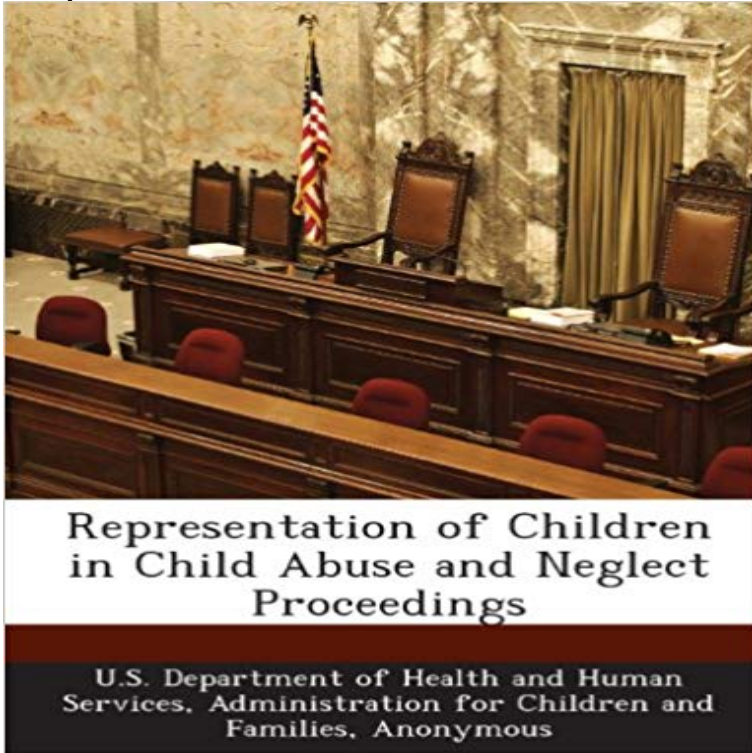


Representation of Children in Child Abuse and Neglect Proceedings
