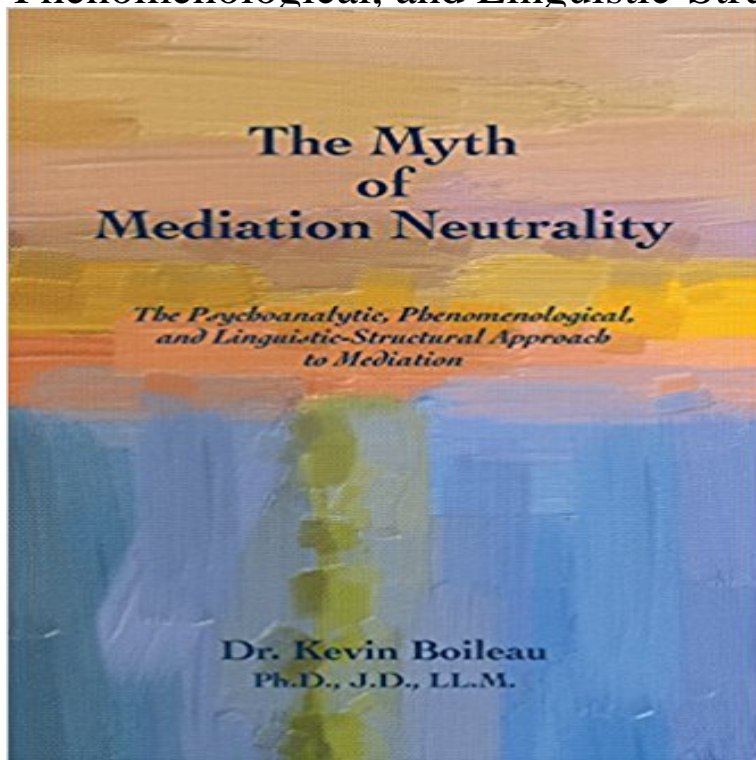


# The Myth of Mediation Neutrality: The Psychoanalytic, Phenomenological, and Linguistic-Structural Approach to Mediation
