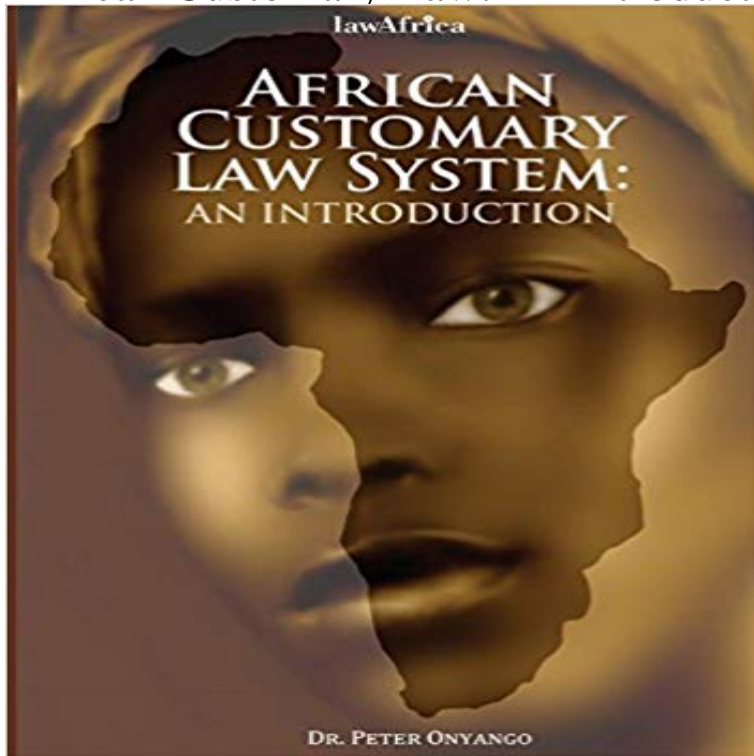


## African Customary Law: An Introduction
